GENERAL: Our Copper 5% is a superior formulation, derived from copper sulfate pentahydrate. This formula provides highly available copper which can be easily utilized by the plants to help prevent copper deficiencies.

**DIRECTIONS FOR USE:** CAUTION This product contains Copper and should be used only as recommended. It may prove harmful when misused. Our Copper 5% is a highly effective copper formulation designed for plant tissue absorption. Specific rate recommendations should be made based on the crops copper demand or tissue analysis. This proprietary formulation is to be used on small fruits and vegetable crops. Seek the advice of a certified crop consultant for application rates and timings for desired crops.

**FOLIAR APPLICATIONS:** Small Fruits: Apply 1.5-2.4L/Ha (20-33fl oz/Acr) in a minimum of 450L(118.9Ga) water/Ha 185.5L(49Ga) water/Acr. Do not spray in temperatures above 25°C (77°F). Repeat applications as needed. Do not exceed 3 applications per season.

**Vegetable crops:** Apply 300ml /Ha (10fl oz/acr) in a minimum of 450L(118.9Ga) water / Ha. 185.5L(49Ga) water/acr). Do not spray in temperatures above 25°C (77°F). Repeat applications as needed. Do not exceed 2 applications per season. Do not apply this product close to waterways or ditches. Do not apply this product in a way that will contact workers or bystanders, either directly or through drift. Copper 5% should be well mixed with water before application. Conduct a jar test for tank mixing with other products.

**FIRST AID:** If on skin: Remove contaminated clothing. Wash skin thoroughly with soap and water. Wash clothing before reuse. If in eyes: Flush with running water for at least 15 minutes while holding eyelids open. Get medical attention. Ingestion: Drink 1-2 glasses of water and induce vomiting.
