Adverse field conditions such as sun-bleached stubble, heavy crop residue, snow, sand or alkaline areas will restrict the visibility of normal foam marks. However, by adding Cornbelt® Foam-Dye Red to the foam solution tank, the user will eliminate this costly and frustrating situation. An added benefit of coloring foam is if by chance the foam marks "drain" or dissipate prior to the return trip across the field, a trail of colored "spots" will remain on the field surface to easily guide the user. Cornbelt® Foam-Dye Red will not reduce the expansion capability of foam solution. This product will not harm the soil or crop.
