25% of the total nitrogen in this product is controlled release. This product is recommended for use as a supplement to a regular fertilizer program only. CORON® 18-8-11 is a liquid fertilizer with unique properties designed for agricultural feeding needs. CORON® 18-8-11 contains nitrogen from controlled release methylene ureas along with additional nutrients to provide prolonged release. CORON® 18-8-11 does not promote surge growth and reduces clipping volumes, while minimizing nitrate leaching. CORON® 18-8-11 is compatible with most fungicides, herbicides and insecticides to allow timesaving tank mix applications. CORON® 18-8-11 is a true liquid solution that is easily applied with standard spray equipment.

GENERAL RECOMMENDATIONS

CITRUS: Apply at a rate of 1-2 gals. per acre.

VEGETABLE CROPS (Including Peppers, Cucumbers, Watermelons, Tomatoes, Cabbage, Collards, Leaf Lettuce and Endive): Apply at a rate of 1-2 qts. per acre. SWEET CORN: Apply at a rate of ½-2 gals. per acre.

SOD (Including Bermuda, Bahia and St. Augustine): Apply at a rate of 1-4 gals. per acre.

STORAGE AND BLENDING INSTRUCTIONS

Store unblended material in closed container between 35°F and 90°F. Do not store in unmarked containers. Dilute with water and blend with other nutrients and pesticides only at the time of application and in the amounts required.

TANK MIXING

Add ½ total water to the tank.

Turn on recirculation line.

Add prescribed amount of CORON® 18-8-11 to tank.

Add liquid flowable materials.

Add any soluble powders.

Bring water to volume and recirculate before spraying.
