PRECAUTIONS

Wash hands thoroughly after handling.

Restricted-entry interval(s): DO NOT enter or allow worker entry into treated areas during the restricted-entry interval(s) stated on the label of the pesticide applied in conjunction with Crimson CA.

Wear a long-sleeved shirt, long pants, chemical-resistant gloves, socks and shoes during mixing, loading, application, clean-up and repair. Gloves are not required during application within a closed cab or cockpit.

FIRST AID

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

GENERAL INFORMATION

Crimson CA may be used at a rate of 1.25-2.5% v/v depending on water hardness. Take water sample to determine water hardness. Control product spray mixtures, their preparation and uses are to be derived from the individual labels for the control products.

Control Product Spray Mixture	Amount of Crimson CA per litre of spray mixture	Remarks
Stonewall 540 and Crush'R 540	1.25-2.5 %	Add Crimson CA as the last ingredient. Consult each product label for use information.

- Use lower rate of Crimson CA with lower levels of water hardness and lighter weed infestation/easy to control weeds. Use higher rate of Crimson CA when water is hard, higher levels of weed infestation and weeds are more difficult to control.

STORAGE

Keep product in original container. Store this product away from food or feed.

DISPOSAL

CONTAINER DISPOSAL:

For recyclable containers:

Do not reuse this container for any purpose. This is a recyclable container and is to be disposed of at a container collection site. Contact your local distributor/dealer or municipality for the location of the nearest collection site. Before taking the container to the collection site:
