CROP AID PLUS provides essential nutrients to emerging plants and is formulated to maximize root growth and nutrient uptake. CROP AID PLUS is recommended for all soil types and crops.

Application Recommendations:

CROP AID PLUS liquid solution is to be applied directly into seed row or sprayed on soil with conventional agriculture sprayers. CROP AID PLUS may be applied to all crops if analytical results suggest a need.

RATE and Frequency:

Apply at 625 ml/hectare twice per season..

Timing:

Apply at pre-seed and in crop

First Aid:
