Delta Technical can be either added directly to the foam extrusion process or separately compounded in a polystyrene resin Concentrate which is then added to the foam extrusion process. Alternatively, Delta Technical can be coated on the polystyrene beads, and incorporated into the foam during the molding process. Finished board will have the following labeling:

Polystyrene foam insulation contains Deltamethrin insecticide to protect the foam from termites and other wood destroying insects.
