GENERAL INFORMATION

Deriva is a water conditioning agent that protects the performance potential of glyphosate, dicamba and 2,4-D from antagonistic metal ions found in hard water and leaf tissue.

For use with Enlist Duo®: Enlist Duo may only be tank-mixed with products that have been tested and found not to adversely affect the spray drift properties of Enlist Duo. A list of those products may be found at EnlistTankmix.com.

The addition of adjuvants to some pesticides and/or fertilizers and their tank mixes may cause phytotoxicity to the foliage and/or fruit of desirable crops. USE RATES

0.5–1% v/v (2–4 quarts) of Deriva per 100 gallons of spray solution.

MIXING

In the absence of specific mixing instructions found on the pesticide label, fill the spray tank with at least 50% of the desired finished carrier volume. When premixing in a mixing vessel or inductor, fill with at least 20% of the desired finished carrier volume. While the carrier is agitating, add tank mix ingredients in the following order:

- 1. Compatibility agent and/or antifoam, if needed
- AMS, dry formulations (WP, DF, WDG, SP), and dry drift retardants
- 3. Dry soluble and suspension fertilizers / micronutrients
- 4. Liquid drift retardants and flowable formulations (F & FL)
- Liquid concentrates, suspension concentrates, microencapsulated and capsule suspension (LC, SC, ME, CS)
- 6. Emulsifiable concentrates (E, EL or EC)
- 7. Solutions and soluble liquids (S or SL)
- 8. Liquid micronutrients and fertilizers
- 9. Water conditioners and other adjuvants (COC, HSOC, MSO, NIS)
- Finish filling to desired spray volume level and continue agitation

STORAGE AND DISPOSAL

Protect product from freezing. If product freezes, warm to room temperature and shake or recirculate before use. Keep containers sealed when not in use. Store in original container only. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal.
