INFORMATION

RTRx Plus is a formulation of essential micronutrients powered by a patented combination of amino acids and proteins which activate several beneficial biological and environmental responses in plants. It is designed for foliar applications to prevent and correct most micronutrients deficiencies to optimize plant health and growth when used as directed.

Maintaining proper levels of micronutrients usually results in increased plant vigor, better yields as well as more desirable quality, size and shelf life. Healthy plants have shown increased resistance to stress caused by excessive dry or wet weather and temperature extremes.

RTRx Plus is believed to be compatible with most agricultural foliar nutritionals, spray adjuvants, fungicides and insecticides. If physical compatibility with another product is unknown, use a jar compatibility test.

DIRECTIONS FOR USE

CITRUS: Use 2 to 4 quarts of **RTRx Plus** per acre in a minimum of 20 gallons of water per acre with ground spray equipment. For aerial application, apply 2 to 4 quarts of **RTRx Plus** in at least 5 gallons of water per acre.

SOD & TURF: Use 2 to 4 quarts of **RTRx Plus** per 100 gallons of water.

ORNAMENTALS: *Foliar Application:* Use 2 to 4 quarts of **RTRx Plus** per 100 gallons of water every 14 to 21 days or as recommended by your Diamond R Representative.

Drip Irrigation Application: Apply 1 Quart per acre on a 7 to 10 day application cycle or as recommended by your Diamond R Representative

FRUITS AND VEGETABLES: *Foliar Application:* Apply 2 to 4 quarts per acre of **RTRx Plus** beginning two weeks after transplants and continue on a 14 day interval or as recommended by your Diamond R Representative.

Drip Irrigation Application: Apply 1 Quart per acre 7 to 14 days after transplant or emergence and continue on a 7 to 10 day application cycle or as recommended by your Diamond R Representative

OTHER CROPS: Consult your Diamond R Representative.
