Basic Information:

Diamond R Ultra MZ Nutritional Spray is a liquid foliar formulation designed for maximum uptake of zinc and manganese to correct and prevent deficiencies in most citrus varieties. If added to the spray tank first, it will aid in lowering the pH of the water. When tank mixing with other products check the compatibilities (jar-test) prior to mixing in the application equipment. The addition of a non-ionic surfactant and/or urea nitrogen will aid in uptake.

Directions For Use:

Diamond R Ultra MZ Nutritional Spray should be applied at 2-3 quarts per acre in enough water to insure thorough coverage without significant runoff. Aerial application: 1-2 quarts per acre in a minimum of 10 gallons of water per acre.

Crop Recommendations

Citrus and Fruit Crops: Mature trees use 2-3 quarts per acre per application in enough water to insure thorough coverage. Repeat applications in summer and fall sprays as needed. Young trees use 2 quarts per 100 gallons of water and apply to

without significant runoff.

Avoid getting in eyes, mucous membranes or on skin. Use with adequate ventilation. Keep container capped when not in use. Keep away from children. Do not contaminate water supplies.

Do not reuse empty container.

Antidotes:
