Citrus and Fruit Crops: Mature trees use 2-3 quarts per acre per application in enough water to insure thorough coverage. Repeat applications in summer and fall sprays as needed. Young trees use 2 quarts per 100 gallons of water and apply to insure thorough coverage without significant runoff.
