FOR GROUND APPLICATIONS ONLY (INCLUDES BACKPACK AND HANDHELD SPRAYERS)

DILIGENCE-EA® NW is specially formulated for use with most fungicides, herbicides and insecticides that are labeled for use in agriculture, forestry, golf course, industrial, non-crop, roadside, turf and ornamentals. DILIGENCE-EA NW is a deposition and drift control agent that reduces the number of spray droplet fines (<105 microns) and increases the Volume Median Diameter (VMD) of the spray droplets. DILIGENCE-EA NW generates a more uniform droplet size spectrum, which results in enhanced deposition and coverage of the spray onto the targeted surface.

NOTE: DILIGENCE-EA NW does not replace the need for additional adjuvants/surfactants in the spray tank.

NOT FOR AQUATIC USE IN WASHINGTON.

DIRECTIONS FOR USE

For optimal tank mix compatibility, add DILIGENCE-EA NW to plain water in a spray tank and fully mix and disperse before adding other tank mix partners, including water conditioning products. DILIGENCE-EA NW can be added and mixed while the tank is partially full. For tank mixtures containing boron, high salt or electrolyte concentrations or fertilizers/micronutrients, a jar test adding the products at the approximate rates and in the intended order of addition should be performed to identify potential incompatibility issues. When performing the jar test, add DILIGENCE-EA NW to the jar first and mix thoroughly before adding other products. Undiluted DILIGENCE-EA NW should not be allowed to contact other undiluted adjuvants, boron-containing products, fertilizers/micronutrients or undiluted pesticide products in eductor systems.

Proper nozzle selection and sprayer operation (pressure and spray angle) combined with good applicator evaluation and decision making regarding wind direction, temperature inversions, application speed and susceptible crops in the area are necessary to maximize the drift reduction potential of DILIGENCE-EA NW.

BACKPACK and HANDHELD SPRAYERS: Add 1 fluid ounce (2 tablespoons) of DILIGENCE-EA NW to 5 gallons of spray mixture.
