PRECAUTIONARY STATEMENTS

Harmful if inhaled. Avoid breathing spray mist. Remove and wash contaminated clothing before reuse.

FIRST AID

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

IF ON SKIN: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

IF SWALLOWED: Call a poison control center or doctor immediately for treatment advice. Have the person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person.

PROHIBITIONS: Do not contaminate water, food or feed by storage, disposal or cleaning of equipment.

STORAGE: Store in original container only and keep sealed. Store in closed storage areas. Storage above freezing is recommended. If product freezes, warm and agitate (recirculate) prior to using.

ADJUVANT DISPOSAL: Wastes resulting from the use of this product may be disposed of through on-site spray application or at an approved waste disposal facility.

CONTAINER DISPOSAL: Do not reuse empty container. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal. GENERAL INFORMATION

Droplex is a spray adjuvant designed to maximize pesticide performance by improving deposition of the spray application onto the intended target. Droplex improves coverage and reduces drift and evaporation of pesticides being applied by ground or air.

Droplex is unique and does not negatively affect spray pattern even when using air assisted type nozzles. Droplex should be used in conjunction with proper spray equipment selection set-up and use including boom height, nozzle type, size and pressure. Along with good judgment and the proper selection and use of spray equipment, Droplex can help professional applicators ensure the maximum performance of pesticides.

DIRECTIONS FOR USE

READ ENTIRE LABEL BEFORE USE SHAKE WELL BEFORE USING

Droplex was developed for use with all herbicides (including desiccants), Insecticides, Fungicides, fertilizers and other plant protectants. If the applicator does not have experience using this product, a phytotoxicity and jar test should be performed to confirm plant safety and tank mix compatibility with a specific spray mix. Droplex should be added after all other products are added but prior to complete filling of the spray tank. Prior to use, read all directions on this label.

Use sites: Agricultural, Aquatic, Forestry, Industrial, Municipal, Non-cropland, Ornamental, Rights of Way, and Turf Drift Reduction:

Rate of Droplex	Spray Solution Gallons per Acre (GPA)
4 – 6 oz./A	5 to 25 GPA
8 - 10 oz./A	25 to 50 GPA
10 oz./A – 16 oz./A*	> 50 GPA

*10 oz./A maximum use in California

The higher rate of Droplex, within the range listed in the above table, is recommended for when using higher rates of pressure or increased GPA of the spray solution. Before mixing pesticides with Droplex, conduct a jar test to determine compatibility.

DO NOT ADD THIS PRODUCT AT A RATE THAT EXCEEDS 1% OF THE FINISHED SPRAY VOLUME.

MAINTAIN AGITATION AT ALL TIMES UNTIL THE CONTENTS OF THE TANK ARE SPRAYED OUT.

Deposition Aid:

For use as a deposition aid only with insecticides and fungicides: 2-4 oz./A for spray of 5-25 GPA.

Mixing

Add Droplex after pesticides or other adjuvants are added but prior to complete filling of the spray tank.

For Direct Injection: Droplex can be applied through injection systems where Droplex is added to one of the system's chemical injection tanks. An in-line mixing chamber is recommended.

- Step 1 Add Droplex to the chemical injection tank.
- Step 2 Pump the correct amount of Droplex into the line.
- Step 3 Pump the proper amount of water, pesticide, and other adjuvants into the line for mixing with Droplex and chemicals before going into the spray boom.
