### GENERAL INFORMATION

ECO-MATE® CROP MIX is a complexed micronutrient designed for foliar or soil application. It is recommended for use as an additive in dry or liquid fertilizers and is compatible with most of the herbicides, insecticides and agricultural chemicals that can be utilized in combination with liquid fertilizers. ECO-MATE® CROP MIX may not be compatible with some liquid fertilizer formulations. A pre-mix jar test is recommended prior to mixing with liquid fertilizer to check compatibility.

ECO-MATE® CROP MIX is an effective pH reduction agent.

**NOTE:** ECO-MATE® CROP MIX cannot be used in liquid fertilizers which contain orthophosphates.

**NOTE:** When applying this product in a tank mix for Organic Production, make sure that all products in the mix are certified or approved for organic production.

### RECOMMENDED CROPS

ECO-MATE® CROP MIX can be applied to the following crops: All vegetables, grapes, row crops, deciduous fruit and nut trees, citrus, avocados, ornamentals and turf.

**DO NOT APPLY NEAR WATER, STORM DRAINS, OR DRAINAGE DITCHES. DO NOT APPLY IF HEAVY RAIN IS EXPECTED. APPLY THIS PRODUCT ONLY TO YOUR LAWN/GARDEN.**

### GENERAL APPLICATION RATES

The following rates have proven successful in correcting deficiencies:

#### SOIL

Maintenance rate.....1-2 quarts/acre

Moderate deficiency.....1/2-1 gallon/acre

Problem field.....1-2 gallons/acre

#### FOLIAR

¼-1 gallon per acre depending on the crop and the severity of the deficiency.

### APPLICATION AND MIXING GUIDE

**HIGH VOLUME SPRAYER:** Use 350-800 gallons of water per acre.

**CONVENTIONAL FIELD CROP SPRAYERS:** Use a minimum of 20 gallons of water per acre.

**LOW VOLUME SPRAYERS:** Use a minimum of 5 gallons of water per acre.

**AIRCRAFT SPRAYING:** Use a maximum of 1 quart of ECO-MATE® CROP MIX per gallon of water.

**MIXING:** In any mixing operation, ECO-MATE® CROP MIX should be introduced in the following sequence:

1. Water
2. ECO-MATE® CROP MIX
3. Other Fertilizers or Pesticides

In mixtures where a compatibility agent is suggested, a product such as BUFFER P.S.™ is recommended.
