GENERAL INFORMATION

EDT CONCENTRATE IS AN EFFECTIVE, EASY-TO-USE DEPOSITION AID FOR INCREASING DEPOSITION AND CANOPY PENETRATION IN SPRAYING OPERATIONS.

One gallon of EDT CONCENTRATE treats up to 200 gallons of spray solution.

Do not use with dormant oils, ULV oils, or where fertilizer is substituted for water as the carrier for pesticide sprays.

NOT FOR AQUATIC USE.

DIRECTIONS FOR USE

Step 1: Select correct EDT CONCENTRATE dosage from chart.

Step 2: Shake EDT CONCENTRATE before using. For optimum results, add wettable powder pesticides before EDT CONCENTRATE. Add liquid pesticides EDT CONCENTRATE. When using liquid micronutrients, a jar test for compatibility and order of addition is strongly recommended. Wetter spreaders may be added before or after EDT CONCENTRATE. EDT CONCENTRATE should be added to the agitating tank mix. For tanks with weak agitation, added EDT CONCENTRATE during the tank filling.

Step 3: Continue to agitate the mix tank before use.

Pesticide label must be followed when spraying pesticides EDT CONCENTRATE can improve deposition of pesticides in the target swath and can reduce, but not totally eliminate drift.

Spray equipment should be rinsed after use. Follow all clean up procedures as noted on label of the pesticide used.
