## GENERAL INFORMATION

EFFICAX® is specially formulated to enhance and improve deposition and soil residual activity for most herbicides and nutritional products, when used in a soil application. It may also be used with fungicides, biological nutrients or amendments and nutritional products as a foliar application to improve deposition and absorption and reduce drift. EFFICAX generates a more uniform droplet size spectrum, which results in enhanced deposition and coverage of the spray on the target surface.

## DIRECTIONS FOR USE

EFFICAX is designed for use in agriculture, forestry, golf course, industrial, non-cropland, roadside, turf and ornamentals.

## USE RATES

**GENERAL:** Use 5-16 fluid ounces of EFFICAX per acre. Rates of 5-8 fluid ounces per acre are considered to be adequate for most uses; however, some pesticides may require higher rates for best results. EFFICAX can replace the need for additional adjuvants in the spray mixture, when used at a rate of 16 fluid ounces per acre. Applications above 8 fluid ounces must be made prior to crop emergence to avoid any potential phytotoxicity.

**DRIFT REDUCTION:** Use 4 fluid ounces per acre.

Always follow the adjuvant use recommendations as shown on the pesticide label.

For pesticides that permit use of an adjuvant at a higher rate, follow instructions on that pesticide label. However, do not add this product at a rate which exceeds 5% of the finished spray volume, except when used as a diluent in dormant, basal, site preparation or other similar applications, per label instructions. Use caution at the higher use rates. When applying to a sensitive crop, first treat a small area to determine if there are any adverse effects to the crop.

## STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage and disposal.

**PRODUCT STORAGE:** Store in original container only and keep tightly sealed. Store in closed storage area.
