GENERAL INFORMATION

ELE-MAX® KSAR™ 0-0-15 is a stabilized solution containing a high concentration of water soluble potash. **ELE-MAX® KSAR™ 0-0-15** is a stable, uniform product with excellent mixing characteristics and utilizes a unique form of potash which exhibits low corrosion characteristics. Foliar fertilization is intended as a supplement to a regular fertilization program and may not, by itself, provide all the nutrients normally required by crops or other intended plants.

ELE-MAX® KSAR™ 0-0-15 is compatible with many liquid fertilizers, foliarly applied micronutrients and pesticides provided that the following mixing precautions are observed:

1. Never mix **ELE-MAX® KSAR™ 0-0-15** with undiluted pesticides.
2. **ELE-MAX® KSAR™ 0-0-15** should be added to the spray tank water prior to the addition of other products.
3. Always "jar test" for compatibility all spray tank mixes before mixing for field applications.

GENERAL RECOMMENDATIONS

ELE-MAX® KSAR™ 0-0-15 may be applied to vegetable and citrus crops.

Recommended rates are:

Vegetable Crops: 5-7 oz./acre

Citrus Crops: 10 oz./acre

ELE-MAX® KSAR™ 0-0-15 may be used on other crops. Consult your HELENA CHEMICAL COMPANY Representative for applications and use rates.

ELE-MAX® KSAR™ 0-0-15 should be used in conjunction with other fertilizer products. **WARNING:** Do not use **ELE-MAX® KSAR™ 0-0-15** in foliar sprays on plants that are sensitive to potassium application.

ELE-MAX® KSAR™ 0-0-15 may be applied by ground (dilute or concentrate) or air (minimum 2 GPA). Apply in enough water for thorough coverage. Local climatic conditions may affect the performance of nutritional sprays. Consult your Helena Chemical Company representative or your local agricultural extension agent for guidance if needed.

Application and Mixing Guide

Mixing: In any mixing operation introduce **ELE-MAX® KSAR™ 0-0-15** in the following sequence:

1. Water
2. **ELE-MAX® KSAR™ 0-0-15**
3. Other Fertilizers and/or Pesticides

If a compatibility agent such as **BLENDIX®** is needed, consult the compatibility agent label for additional mixing instructions.
