GENERAL INFORMATION

EMBRECE-EA™ utilizes patented technology and is designed to quickly wet and spread spray droplets across the surface of the foliage, resulting in enhanced coverage and a more uniform spray deposit. These attributes can lead to increased absorption and translocation of various agricultural chemicals and more consistent pesticide performance.

DIRECTIONS FOR USE

Mixing Instructions: Start with a clean sprayer. EMBRECE-EA should be added to the spray tank according to the mixing order recommended on the pesticide product label. Agitation is required while mixing and during the spray application.

Rates of EMBRECE-EA may vary with plant characteristics, target site and environmental conditions at the time of application. In most situations, the minimum rate of EMBRECE-EA, as specified on this label, will be sufficient in providing uniform coverage and best results.

Use higher rates under, but not limited to, the following situations:

- Use with systemic pesticide products
- Applications made under adverse conditions
- When a pesticide label recommends a higher rate of non-ionic surfactant

Note: When mixing EMBRECE-EA with other agricultural chemicals, all product labels and directions should be read and followed to ensure compatibility and proper usage.

USE RATES

FUNGICIDES: Use 1-2 pints per 100 gallons of spray mixture.

INSECTICIDES AND MITICIDES: Use 1-2 pints per 100 gallons of spray mixture.

Always follow the use recommendations as shown on the pesticide label.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage and disposal.

STORAGE: Store in original container only and keep tightly sealed. Store in closed storage area.
