GENERAL INFORMATION

Enhanced Sulfate is an ammonium sulfate product formulated for use with certain herbicides as recommended on the herbicide labels. Observe all precautions and geographical restrictions on labels of herbicides and other additives. The ammonium sulfate equivalent of **Enhanced Sulfate** is 3.4 lbs per gallon.

DIRECTIONS FOR USE SHAKE WELL BEFORE USING

Use recommended rates of herbicide and additives.

Add **Enhanced Sulfate** to tank when water level is 3/4 of the desired amount and agitation has been turned on, but before herbicide is added.

Enhanced Sulfate may be corrosive to metal parts of sprayer or other equipment. Thoroughly flush the tank, pump, boom, nozzles, and entire spray system with water.

Roundup, Landmaster, Bronco, Fallowmaster, Deploy, and Honcho: 5 gallons of **Enhanced Sulfate** plus 95 gallons of water are equivalent to 17 lbs of ammonium sulfate per 100 gallons of water.

Poast: 3 quarts of **Enhanced Sulfate** per acre are approximately equivalent to 2 1/2 lbs of ammonium sulfate per acre.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

Storage: For best results, store at temperatures above 35° F and out of direct sunlight. If stored at colder temperatures, it may be necessary to redissolve crystals by gradually warming to 70° F and agitating container. Avoid high temperature storage.

Disposal: Triple rinse empty container, adding water to spray tank. Do not re-use empty container. Wash thoroughly with water and detergent. Puncture, make unusable; dispose of container in an approved waste disposal plant. Avoid release to the environment. Dispose of contents/container to an approved waste disposal plant.
