GENERAL INFORMATION

This product is designed to aid in the application and uptake of fertilizer and micronutrients.

This liquid material is designed to be used at a rate of 21 oz. per acre, but application rates may vary depending on actual conditions. This product is intended for use with custom blends.

SUGGESTIONS DIRECTIONS

TURF

Spray (For use after Lime or Gypsum applications): This liquid material is designed to be used at a rate of 21 oz. per acre followed by a 1/4 to 1/2" of irrigation, but application rates may vary depending on actual conditions. This product is intended for use with custom blends.

Injection: Product is to be injected into irrigation system at a rate of 50 ppm to 200 ppm/gallon of water flow. Applications are to be made once every two to four weeks for best results.

The equation is: $GPM \times ((60 \times 128) / 1,000,000) \times ppm = oz/hr$

Multiply the GPM of the well by 60 to get gallons per hour, then multiply that by 128 to get oz. per hour, then divide by 1,000,000 and multiply by the desired ppm. The middle part of the equation equals 0.00768.

DO NOT APPLY NEAR WATER, STORM DRAINS, OR DRAINAGE DITCHES. DO NOT APPLY IF HEAVY RAIN IS EXPECTED. APPLY THIS PRODUCT ONLY TO YOUR LAWN, GARDEN, OR GOLF COURSE.
