DIRECTIONS FOR USE

(Shake well before using)

USE RATES

EVENT should be used at 4-5 quarts/100 gallons of spray solution (1.00-1.25% v/v).

MIXING INSTRUCTIONS

IMPORTANT - Add **EVENT** to the spray tank first before adding any other tank mix product, unless the tank mix pesticide(s) or additives direct otherwise.

Mixing Order

- 1. Fill tank 1/2 full of water and begin agitation.
- 2. Add the required amount of **EVENT** while agitating.
- 3. Continue filling spray tank with water and add the tank mix components as directed on the pesticide label(s).

NET CONTENTS:

STORAGE & DISPOSAL

Store product in original container. Do not store near heat or open flame. Do not reuse container. Do not contaminate water, food or feed by storage or disposal. Keep packaging closed, securely fastened and upright. Product may suspend in layers if stored below $0^{\circ}F$.

Triple rinse (or equivalent) prior to disposal. Add rinsate to spray tank. Offer container for recycling or dispose of in accordance with all applicable regulations. If burned, stay out of smoke.

FIRST AID
