## HAZARD AND PRECAUTIONARY STATEMENTS

## PERSONAL PROTECTIVE EQUIPMENT (PPE)

Applicators and other handlers must wear splash-proof chemical safety goggles, face protection, chemically-resistant gloves, long-sleeved shirt, pants, socks and shoes. Consult the SDS for further information.

## FIRST AID

**If Swallowed:** Call a poison control center or doctor immediately for treatment advice. Have the person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person.

**If In Eyes:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

**If On Skin or Clothing:** Take off contaminated clothing and wash it before reuse. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

**If Inhaled:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control center or doctor for further treatment advice.

## HAVE THE PRODUCT CONTAINER OR LABEL WITH YOU WHEN CALLING A POISON CONTROL CENTER OR DOCTOR, OR GOING FOR TREATMENT.

## GENERAL INFORMATION

**Functions:** Spray equipment and tank cleaner

**Clear-UP** cleans and removes pesticide residue from tanks, hoses and pumps. This may reduce the risk of cross contamination.

## DIRECTIONS FOR USE

For cleaning and maintenance equipment used to pump, store, transport and apply pesticides. Add to spray tank with clean water and follow cleaning instructions below.

## USE RATES

**Heavy Residue Removal:** 2 pints per 50 gallons of clean water

**Regular Cleaning:** 1 pint per 50 gallons of clean water

**Clear-UP** contains detergents that can cause foam. Adding **Head-OUT™** anti-foam/defoamer during the cleaning process may be useful.

## CLEANING INSTRUCTIONS

- Collect all rinsate if cleaning procedures are done on concrete. If clean out is being conducted in the in-field, skip to step 3.
- Drain the spray tank, line and hoses and loosen any visible residues.
- Pre-rinse tank with 100-200 gallons of clean water. Recirculate for at least 10 minutes and spray half of the rinsate through the nozzles.
- Remove end caps. Spray remaining 50-100 gallons through boom.
- Remove, soak and clean nozzles, screens and strainers using **Clear-UP** as the cleaning agent.
- Add 100-200 gallons of clean water and the appropriate rate of **Clear-UP**. Maintain agitation. Circulate for at least 15 minutes and spray half of the rinsate through the nozzles. Spray the remaining rinsate through the boom sections until tank is empty.
- Drain all lines, and pump and dispose of rinsate properly.
- Rinse nozzles, screens, and end caps with water and reinstall.
- Add 50-100 gallons of water to the tank and recirculate. Flush solution through the boom, hoses and nozzles until tank is empty.
- Drain all lines and pump. Dispose of rinsate properly. Remove excess rinsate with pump or wet/dry vacuum. Repeat if necessary.

## STORAGE AND DISPOSAL

**Storage:** Keep containers sealed when not in use. Store in original container only. Store locked up. Store in a corrosion resistant container with a resistant inner liner.

**Disposal:** Do not reuse empty container. Triple rinse (or equivalent) during mixing and loading. Decontaminated containers and materials must be disposed of in a manner allowed by local, state and federal laws and regulations.
