**GENERAL INFORMATION:**

*Inhabit Fe* is a concentrated and highly available form of iron in a unique peptide chelation system to enhance availability and reduce leaching in a wide range of pH and soil environments. It may be utilized as in furrow solution as part of a system to treat iron deficiency chlorosis (IDC) in soybeans in addition to treating iron deficiencies in other crops.

**DIRECTIONS FOR USE:**

Read all label directions carefully before using this product. This product is intended for use in all soils and crops.

Results are best when applied directly in the root zone.

Do not exceed the recommended application rate for this product. Do not apply this product undiluted.

**Always start with equipment that has been thoroughly cleaned and add to 50% water.**

**For best results and compatibility with starter fertilizer, use with *Inhabit P* or *Inhabit Start* (with proper water dilution designated on those respective labels).**

**ADDITIONAL IDC SOLUTIONS**

Foliar apply Atarrus at a rate of 16 oz. (475 mL) per acre to enhance iron uptake.

Foliar apply Nourish Fe at 20 to 36 oz. (591 - 1064 mL) for an efficient in season iron source.

Rates are general. To address crop specific needs or deficiency issues consult with an agronomist.

**MIXING INSTRUCTIONS:**

**Always start with equipment that has been thoroughly cleaned.** Fill the tank with at least 50% of the final water volume unless otherwise stated on the specific product label. While the carrier is agitating, add tank mix ingredients in the following order:

1. Antifoam and / or compatibility agent
2. Dry formulations (WP, DF, WDG, SG, SP) and ammonium sulfate
3. Flowable formulations (F & FL), liquid concentrates or suspensions (LC, ME, SC, CS)
4. Emulsifiable concentrates (E or EC)
5. Add *Inhabit Fe* and other soluble liquids (S or SL)
6. Surfactants, water conditioners and other adjuvants
7. Finish filling and continue agitation

**STORAGE AND DISPOSAL:**

**Storage:** Store this product between temperatures of 50 °F (10 °C) and 90 °F (30 °C). Store in a cool, dry place and out of direct sunlight. Do not store diluted product. Stable under recommended storage conditions.

**Disposal:** Do not reuse empty container. Triple rinse (or equivalent) during mixing and loading. Decontaminated containers and materials must be disposed of in a manner allowed by local, state and federal laws and regulations.
