**FIRST AID:**

**If In Eyes:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

**GENERAL INFORMATION:**

**INHABIT P FNV** supplies phosphorus to crops. **INHABIT P FNV** is designed to be applied by both soil and/or foliar application. **INHABIT P FNV** supplies phosphorus to crops and should be applied when tissue and soil analysis identifies the need and proper rate of application for this product.

**DIRECTIONS FOR USE:**

Shake well before use. Best results will be obtained when application is concentrated in the active root zone or on the leaf surface. Can be applied in combination with compatible plant growth regulators, pesticides, or other liquid fertilizers. If compatibility is in question, jar test a small quantity. This product is intended as a supplement to a complete fertilization program and will not, by itself, provide all the nutrients normally required by agricultural crops.

**APPLICATION INSTRUCTIONS:**

Applications can be made as often as every 7 to 10 days as needed. Apply foliar sprays with sufficient water to ensure uniform coverage without running off leaf surfaces. For maximum results, apply in the early morning or in the evening when air temperatures are optimum for foliar application. Consult your local FBN Representative or other agricultural specialist for crop-specific recommendations.

**Note:**

- Do not apply this product foliarly in concentrations greater than 5%.
- Do not apply during the hottest time of the day or to plants under drought or flood stress.
