General: FIGHTER-F 10 is designed to effectively control foam in water, oil, fertilizer and pesticide spray mixtures. FIGHTER-F 10 will reduce mixing time by facilitating faster and more accurate filling. Foam can effect calibration and metering of spray mixtures. FIGHTER-F 10 will reduce waste and exposure to pesticides contained in foam running over the top of the tank.

Directions for Use: Use 1 to 6 ounces of FIGHTER-F 10 per 100 gallons of spray mixture. For best results, add FIGHTER-F 10 to the water before adding the agricultural chemicals. Agitation will aid dispersion. Rate may need to be adjusted. Effectiveness of FIGHTER-F 10 depends upon temperature, viscosity and composition of spray mixture. Decrease or increase rate until desired foam control is obtained.

Storage: Store in cool, dry place. Store in original container. Keep container tightly closed. Do not reuse empty container.

Disposal: Do not contaminate water, food or feed by storage or disposal. Dispose of contents/container on-site or at an approved waste disposal facility. Triple rinse (or equivalent) adding rinse water to spray tank. Offer container for recycling or dispose of in sanitary landfill or by other procedures approved by appropriate authorities. Recycling decontaminated containers is the best option of container disposal. The Agricultural Container Recycling Council (ACRC) operates the national recycling program.
