**General:** FIGHTER-F DRY is a concentrated dry antifoaming — defoaming agent designed to prevent and eliminate foam in water, oil, fertilizer and pesticide tank mixtures in agricultural and horticultural sprays. FIGHTER-F DRY will reduce mixing time by facilitating faster and more accurate filling. Foam can effect calibration and metering of spray mixtures. FIGHTER-F DRY will reduce waste and exposure to pesticides contained in foam running over the top of the tank.

**Directions for Use:** Use a shake or two of FIGHTER-F DRY per 100 gallons of spray mixture. For best results, add FIGHTER-F DRY to the water before adding the agricultural chemicals. Agitation will aid dispersion. Rate may need to be adjusted. Effectiveness of FIGHTER-F DRY depends upon temperature, viscosity and composition of spray mixture. Decrease or increase rate until desired foam control is obtained.

**Storage:** Store in cool, dry place. Store in original container. Keep container tightly closed. Do not reuse empty container.

**Disposal:** Do not contaminate water, food or feed by storage or disposal. Wastes may be disposed of on-site or at an approved waste disposal facility. Triple rinse (or equivalent) adding rinse water to spray tank. Offer container for recycling or dispose of container in sanitary landfill or by other procedures approved by appropriate authorities. Recycling decontaminated containers is the best option of container disposal. The Agricultural Container Recycling Council (ACRC) operates the national recycling program.
