Corn 3 oz/ unit of seed (50 lbs)	<p>FLOTEGIC 1-10-0 can be mixed with most fungicides and pesticides. Mix powder well enough to ensure even coverage on seed.</p> <p>As a planter box treatment: Apply to seed in the planter box, the seed bag, or in a mixing pail.</p> <p>As a seed finisher: Apply in a manner that allows the treatment to cover all seed surfaces. Suggested application points include at the finished slurry treatment transition, conveyor transitions, or any other seed flow points where seed will be mixed prior to deposit into the final seed storage container. Rates may need to be adjusted depending on the seed treatment operation.</p>
