GENERAL INFORMATION

FOLI-GRO® CALCIUM 6% is formulated primarily for foliar applications to prevent or correct calcium deficiencies in a wide range of agronomic and ornamental plants. Its use is suggested as a supplement to a regular, balanced fertilizer program to enhance yields and improve quality.

Application of **FOLI-GRO CALCIUM 6%** is a means of obtaining a quick response to needed elements. Foliar applications of **FOLI-GRO CALCIUM 6%** may be particularly beneficial during periods of peak nutrient demand, for crops grown on soils having poor nutrient availability or to crops suffering from a weakened root system.

Avoid foliar nutrient applications to crops during periods of moisture, salinity or heat stress. Applications of foliar nutrients to sensitive crops such as leafy vegetables or soft-skinned fruit during periods of excessive temperatures may cause cosmetic injury. **FOLI-GRO CALCIUM 6%** should be used as part of a comprehensive Total Nutrition System® for optimizing plant growth, development, yield and quality.

VEGETABLES: Blackheart of celery, lettuce tipburn, internal tipburn of cabbage, blossom-end rot of tomatoes and peppers, and cavity spot of carrots and parsnips.

FRUIT: Bitter pit of apples, cracking of sweet cherries, cork spot of Anjou pears, soft tip and post-thinning drop of stone fruit, and water berry of grapes.

DIRECTIONS FOR USE

FOLI-GRO CALCIUM 6% may be applied as a foliar spray by air or by ground. Maintain agitation to provide uniform distribution within the spray tank. Thorough and even spray coverage is essential for maximum nutrient uptake and crop safety. Always include a high quality wetting agent, such as R-11® or SYL-COAT™, at recommended rates.

Optimum rate of application will vary based on a variety of factors including degree of need or deficiency, growth stage, yield potential, environmental conditions, existing soil fertility levels, etc.

CONVENTIONAL SPRAYER: Apply the recommended amount of **FOLI-GRO CALCIUM 6%** with a minimum of 20 gallons of water per acre.

CONCENTRATE OR AERIAL: Usually 5 gallons of water per acre is sufficient to apply the recommended amount of **FOLI-GRO CALCIUM 6%**. If less water is used, a slight burning of the foliage may occur. Aerial applications should not exceed 1 quart per gallon of water.

BLUEBERRIES, CRANBERRIES, AND STRAWBERRIES: Apply 1-2 quarts of **FOLI-GRO CALCIUM 6%** per acre.

COTTON: Apply 2-4 quarts of **FOLI-GRO CALCIUM 6%** per acre at square to peak bloom to increase boll set.

GRAPES: Apply 1-2 quarts of **FOLI-GRO CALCIUM 6%** per acre by ground at the veraison stage of development. A second application of 2 quarts per acre 30 days prior to harvest may result in earlier maturity. Do not apply after fruit formation on fresh market grapes.

TREE FRUIT (including but not limited to apples, cherries and pears): Apply 2-4 quarts of **FOLI-GRO CALCIUM 6%** every 30 days starting 10-14 days after bloom. Repeat as needed.

TREE NUTS: Apply 1-4 quarts of **FOLI-GRO CALCIUM 6%** per acre as needed.

VEGETABLES: Apply 1-2 pints of **FOLI-GRO CALCIUM 6%** per acre per week in the normal spray program. For specific crop recommendations consult with the Wilbur-Ellis representative in your area.

ORNAMENTALS:

Turf: Apply 1 pint of **FOLI-GRO CALCIUM 6%** per 1,000 sq. ft. of turf. Use a minimum of 5 gallons of water per 1,000 sq. ft.

Trees and Shrubs: Apply 1-2 pints of **FOLI-GRO CALCIUM 6%** per 500 gallons of water. Spray to cover.

NOTE: **FOLI-GRO CALCIUM 6%** may acidify spray solutions. Do not mix with sulfate or phosphate-based acidifying agents, buffering agents, or fertilizers.

COMPATIBILITY

FOLI-GRO CALCIUM 6% is compatible with many co-applied nutrients and plant protection products. Always jar test new combinations for compatibility prior to field mixing. **FOLI-GRO CALCIUM 6%** is formulated to achieve an acidic spray solution. Final spray solution pH will vary depending on rate, water volume and water quality. Do not combine with copper plant protection products if spray solution has a pH of 7.0 or less. Avoid tank mixing with liquid lime sulfur. Do not apply with amine form of 2,4-D or Banvel®. May be incompatible with sulfate or phosphate containing fertilizers or spray adjuvants.
