GENERAL INFORMATION

FOLI-GRO® CARBO-MAG™ is formulated primarily for foliar applications to prevent or correct magnesium deficiencies in a wide range of agronomic and ornamental plants. Its use is suggested as a supplement to a regular, balanced fertility program to enhance yields and improve quality. Application of FOLI-GRO CARBO-MAG is a means of obtaining a quick response to needed elements.

Foliar applications of FOLI-GRO CARBO-MAG may be particularly beneficial during periods of peak nutrient demand, for crops grown on soils having poor nutrient availability or to crops suffering from a weakened root system.

Avoid foliar nutrient applications to crops during periods of moisture, salinity or heat stress. Applications of foliar nutrients to sensitive crops such as leafy vegetables or soft-skinned fruit during periods of excessive temperatures may cause cosmetic injury.

FOLI-GRO CARBO-MAG should be used as part of a comprehensive Total Nutrition System® for optimizing plant growth, development, yield and quality.

DIRECTIONS FOR USE

FOLI-GRO CARBO-MAG may be applied as a foliar spray by air or by ground. Maintain agitation to provide uniform distribution within the spray tank. Thorough and even spray coverage is essential for maximum nutrient uptake and crop safety. Always include a high quality wetting agent such as R-11® or SYL-COAT™ at recommended rates.

Do not apply FOLI-GRO CARBO-MAG when ambient temperatures are expected to exceed 85°F before application completely dries on foliage. Optimum rate of application will vary based on a variety of factors including degree of need or deficiency, growth stage, yield potential, environmental conditions, existing soil fertility levels, etc.

Exercise caution when applying FOLI-GRO CARBO-MAG to any crop during bloom, as many factors can affect fruit set and final fruit quality.

AERIAL APPLICATIONS AND GROUND SPRAYS: Use a minimum of 5 gallons of water per acre.

DILUTE SPRAYS: Use a minimum of 30 gallons of water per acre.

CROPS (Including Row, Field and Forage Crops; Vegetable Crops; Fruit Crops; and Other Crops): Apply 1-3 quarts of FOLI-GRO CARBO-MAG per acre per application. Do not exceed 1 gallon of FOLI-GRO CARBO-MAG per acre per application and no more than 8 gallons should be used per season. The number and frequency of applications will determine application rates. Always apply FOLI-GRO CARBO-MAG towards the end of an irrigation cycle. Please consult your local Wilbur-Ellis representative for specific recommendations.
