GENERAL INFORMATION

FOLI-GRO® KILO™ is designed primarily for foliar applications to prevent or correct potassium deficiencies in a wide range of agronomic and ornamental plants. Application of **FOLI-GRO KILO** is a means of obtaining a quick response to needed potassium. Foliar applications of **FOLI-GRO KILO** may be particularly beneficial during periods of peak nutrient demand, for crops growing on soils having poor nutrient availability or to crops suffering from a weakened root system.

FOLI-GRO KILO should be used as part of a comprehensive Total Nutrition System® for optimizing plant growth, development, yield and quality.

DIRECTIONS FOR USE

FOLI-GRO KILO may be applied as a foliar spray by air or by ground. Maintain agitation to provide uniform distribution within the spray tank. Use of a high quality CPDA approved spreader, such as R-11®, at recommended rates to improve spray cover is usually advised. Do not apply when plants are under excessive heat or moisture stress.

Applications of foliar nutrients to leafy vegetables or soft-skinned fruit during periods of excessive temperatures may cause cosmetic injury. It is advised that **FOLI-GRO KILO** be diluted with water at no less than 2 parts water to 1 part **FOLI-GRO KILO**.

Timing of treatments should be based on crop nutrient demand, prevailing environmental conditions, plant tissue analysis data or other information that indicates a need for fast-acting, supplemental potassium.

FIELD AND ROW CROPS: Apply 1-8 quarts per acre before crops attain full canopy and then 1-3 gallons per acre as needed.

VEGETABLE CROPS: Apply 1-4 quarts per acre for most vegetable crops. Rates as high as 3 gallons per acre may be used on crucifers.

DECIDUOUS FRUIT AND NUT CROPS: Apply 1-2 gallons per acre from bud swell to early bloom and 1-3 gallons per acre post-bloom. Rates as high as 5 gallons per acre may be used post-harvest to leaf senescence.

CITRUS: Apply 1-10 gallons per acre as needed. It is advised that for citrus applications, **FOLI-GRO KILO** be diluted with water at no less than 10 parts water to 1 part **FOLI-GRO KILO**.

GRAPES: Apply 1-2 gallons per acre as needed. Rates as high as 5 gallons per acre may be used post-harvest to leaf senescence.

OLIVES: Apply 1-3 gallons per acre as needed.

FOLI-GRO KILO is compatible with many co-applied nutrient sources as well as plant protection products. Always jar test new combinations for compatibility prior to field mixing.
