**FORAGE CROPS (Including but not limited to Alfalfa, Clover and Pasture):** Apply 2-4 pints per acre at the appropriate stages of growth and development.

**FRUIT AND NUT CROPS (Including but not limited to Almonds, Hazelnuts, Grapes, Pecans, Walnuts, Caneberries and Strawberries):** Apply 1-4 quarts per acre at the appropriate stages of growth and development.

**GRASS SEED AND TURF:** Apply 1-4 pints of FOLI-GRO MICRO-MIX per acre in the normal spray program. For specific recommendations consult with the Wilbur-Ellis representative in your area.

**LEGUME CROPS (Including but not limited to Beans, Chickpeas, Lentils and Peas):** Apply 1-4 pints per acre at the appropriate stages of growth and development to correct certain micronutrient deficiencies. Do not apply after pod set.

**SMALL GRAIN CROPS (Including but not limited to Barley, Oats, Rice, Rye and Wheat):** Apply 2-4 pints FOLI-GRO MICRO-MIX per acre per application through the growing season, but before flag leaf emergence, as a maintenance program. Frequent applications at 1-½ quarts per acre may be needed to correct deficiencies once they occur. Use a minimum of 10 gallons of water per acre with ground spray equipment. One percent urea nitrogen will aid leaf penetration.

**VEGETABLE CROPS (Including but not limited to Carrots, Cole Crops, Cucurbits, Lettuce, Onions, Melons, Potatoes and Tomatoes):** Apply 1-2 pints per acre at the appropriate stages of growth and development, but before fruit set.

### FIRST AID

In all cases, call a poison control center or doctor for further treatment advice.

**IF SWALLOWED,** call a poison control center or doctor immediately. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to by a poison control center or doctor.
