GENERAL INFORMATION

FoliMar[®] Slo-N + K is designed for foliar applications for select crops. FoliMar[®] Slo-N + K should be used during periods of high nutrient demand or to correct nutrient deficiencies in many crops. Use FoliMar[®] Slo-N + K as needed for a quick response for elements. To enhance application, use non-ionic spreader such as Surf-90. Do not apply product if high temperature is over 85° in a 3-day period. Concentration should not exceed over 30%.

DIRECTIONS FOR USE

All rates should vary based on the severity of soil and plant tissue deficiency and degree of weather extremes. FoliMar[®] Slo-N + K can be soil applied as a banded side-dress or broad cast of treatments based on crop demand. Consult your Mar Vista distributor or agronomist for specific fertility recommendation on specific crops. Use in accordance with recommendations of a qualified individual or institution such as, but not limited to, a certified crop advisor, agronomist, university crop extension publication, or apply according to recommendations in your approved nutrient management plan.

When tank mixing other products, "Jar Test" proportionally mixed components to confirm compatibility.

FOLIAR APPLICATION

FoliMar[®] Slo-N + K may be applied by air or ground spray. Use appropriate volume of water for application and method and the crop. Apply in a water volume for thorough coverage, but avoid excessive run-off.

Trees and Vines: Apply 1 gallon per acre from bud swell to early bloom. Apply 1-4 quarts per acre during growing season. Post harvest and dormant applications use up to 5 gallons per acre.

Field and Row Crops: Apply 1-4 quarts per acre until full canopy then use 2-8 quarts per acre as needed.

Olives: Apply 1-2 gallons per acre as needed.
