FIRST AID

If Swallowed: Immediately call a POISON CENTER/doctor or Chemtrec. Rinse mouth. Have person sip a glass of water if able to swallow. Do NOT induce vomiting, unless told to by a poison control center or doctor. Do not give anything to an unconscious person.

If In Eyes: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Immediately call a POISON CENTER, doctor or Chemtrec.

GENERAL INFORMATION—FS Interface is a low-use-rate, activator adjuvant blend designed to maximize the performance of glyphosate, and its tank mix partners, on hard-to-control weed species. FS Interface effectively replaces the need for ammonium sulfate with glyphosate and glyphosate tank mixes by sequestering antagonistic hard water ions, maximizing cuticle penetration of both water-soluble and oil-soluble herbicides, and protonating weak acid herbicides for rapid absorption and transportation.

USE RATES—Apply FS Interface at .125% - .75% v/v (1-6 pints per 100 gal. of spray solution).

MIXING INSTRUCTIONS— In the absence of specific mixing instructions found on the pesticide label, fill the spray tank with at least 50% of the desired finished carrier volume. When premixing in a mixing vessel or inductor, fill with at least 20% of the desired finished carrier volume. While the carrier is agitating, add tank mix ingredients in the following order:

1. Compatibility agent and/or antifoam, if needed
2. AMS, dry formulations (WP, DF, WDG, SP), and dry drift retardants
3. Dry soluble and suspension fertilizers / micronutrients
4. Liquid drift retardants and flowable formulations (F & FL)
5. Liquid concentrates, suspension and microencapsulated (LC, SC, ME)
6. Emulsifiable concentrates (E, EL or EC)
7. Solutions and soluble liquids (S or SL)
8. Liquid micronutrients and fertilizers
9. Water conditioners and other adjuvants (COC, HSOC, MSO, NIS)
10. Finish filling to desired spray volume level and continue agitation

STORAGE AND DISPOSAL— Keep container closed tightly when not in use. Prevent water from being introduced into the contents of this container. Do not reuse empty container. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal.
