FIRST AID

GENERAL INFORMATION

FS MaxSupreme is a liquid activator adjuvant specifically formulated to maximize pesticide performance on a wider range of weed species by eliminating spray particle bounce, thus providing superior adhesion of the spray solution to the leaf surface while providing the required amount of ammonium and sulfate ions. For use with Enlist Duo®: Enlist Duo may only be tank-mixed with products that have been tested and found not to adversely affect the spray drift properties of Enlist Duo. A list of those products may be found at EnlistTankmix.com.

DIRECTIONS FOR USE

The addition of adjuvants to some pesticides and/or fertilizers and their tank mixes may cause phytotoxicity to the foliage and/or fruit of desirable crops. Before using **FS MaxSupreme**, the applicator or crops advisor must have experience with the pesticide combination, including **FS MaxSupreme**, or must have conducted a phytotoxicity test.

USE RATES

Ground Application: 1.25 - 2.5% (1.25 - 2.5 gallons) of **FS MaxSupreme** per 100 gallons of spray solution.

Aerial Application: 2.5–5% (2.5–5 gallons) of **FS MaxSupreme** per 100 gallons of spray solution.

FS MaxSupreme provides 8.5 lbs. of dry ammonium sulfate per 2.5 gallons.

MIXING

In the absence of specific mixing instructions found on the pesticide label, fill the spray tank with at least 50% of the desired finished carrier volume. When premixing in a mixing vessel or inductor, fill with at least 20% of the desired finished carrier volume. While the carrier is agitating, add tank mix ingredients in the following order:

1. Compatibility agent and/or antifoam, if needed
2. AMS, dry formulations (WP, DF, WDG, SP), and dry drift retardants
3. Dry soluble and suspension fertilizers / micronutrients
4. Liquid drift retardants and flowable formulations (F & FL)
5. Liquid concentrates, suspension and microencapsulated (LC, SC, ME)
6. Emulsifiable concentrates (E, EL or EC)
7. Solutions and soluble liquids (S or SL)
8. Liquid micronutrients and fertilizers
9. Water conditioners and other adjuvants (COC, HSOC, MSO, NIS)
10. Finish filling to desired spray volume level and continue agitation

STORAGE AND DISPOSAL

Protect product from freezing. If product freezes, warm to room temperature and agitate before use. Keep containers sealed when not in use. Store in original container only. Do not reuse empty container. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal.
