FS Transform Plus sequesters antagonistic hard water ions, provides additional ammonium ions for improved herbicide uptake and reduces drift risk to ensure optimum performance of glyphosate-based herbicides.

USE RATES—Using the guidelines below, mix FS Transform Plus at 1–4 quarts per 100 gallons of spray solution (0.25–1.0% v/v).
