GENERAL INFORMATION—FS Transform is a low-use-rate, ammonium sulfate replacement product that combines water conditioning agents and ammonium ions in a convenient premix formulation. FS Transform is designed to effectively replace the need for ammonium sulfate with weak acid herbicides such as glyphosate, dicamba and phenoxies by sequestering antagonistic hard water ions and providing ammonium ions to ensure enhanced uptake of certain pesticides.

DIRECTIONS FOR USE—Always mix and apply this product in accordance with the instructions found on the pesticide label regarding adjuvants. In the absence of specific instructions follow the application and mixing guidelines below.

APPLICATION RATES—Using the guidelines below, apply FS Transform at 1–2 quarts per 100 gallons (0.25–0.5% v/v).

NOTE: Use the higher use rates:

- —When replacing 17 lbs of ammonium sulfate per 100 gallons of spray solution
- --When nitrogen responsive weed species, such as velvetleaf, are present or weeds are under weather stress conditions

Use the lower use rates:

—When replacing 8.5 pounds of ammonium sulfate per 100 gallons of spray solution

MIXING INSTRUCTIONS—In the absence of specific mixing instructions found on the pesticide label, fill the spray tank 1/2 to 3/4 full of desired water volume. While the water is agitating, add tank mix ingredients in the following order:

- 1. FS Transform.
- 2. Water-soluble packets, dry flowables and dispersible granule pesticides.
- 3. Flowable pesticides.
- 4. Water-soluble pesticides.
- 5. Emulsifiable concentrate pesticides.
- 6. Finish filling spray tank to desired level and continue agitation.

STORAGE AND DISPOSAL—Keep container closed tightly when not in use. Prevent water from being introduced to the contents of this container. Protect product from freezing. Store in original container only and do not reuse empty container. Rinse container thoroughly, disposing of rinsate and the containers in accordance with federal, state and local regulations.
