APPLICATION IRRIGATION WATER

Solid Set, Overhead, Drip, Sprinkler or Pivot Irrigation Systems: Dissolve Gainer WIF 'K' in mix tank and apply in irrigation water. Use of anti-siphon or back-check valve is required to prevent material from contaminating primary water supply.

DIRECTIONS FOR USE

Mix 1 lb. of soluble Gainer WIF 'K' in one gallon of water prior to application or adding to other liquid fertilizer materials. Always use a jar test to determine compatibility.

Use 1 to 30 lbs. of Gainer WIF 'K' per acre, per application depending upon crop removal, tissue tests, and soil test levels. It is not recommended to apply more than 6 applications at the Maximum Rate per year.

Gainer WIF 'K' can be foliar applied at the following rates:

Use 5 to 10 lbs of product per acre. Mix in 15 to 20 gallons by ground, 3 -5 gallons by air. When mixing, do not exceed 2 lbs of Gainer WIF 'K' per gallon of water. If micronutrients are needed, an EDTA chelated product must be used to insure physical compatibility.
