#### On Livestock

GOATS, SHEEP, CATTLE (Beef and Dairy), HOGS AND HORSES To Control Horn Flies, Face Flies, House Flies, Mosquitoes and Gnats: Apply a light mist sufficient to wet the surface of the hair. For face flies, spray face and head, but do not spray into eyes.

To Control Stable Flies, Horse Flies and Deer Flies: Apply 2 fluid ounces per adult animal, sufficient to wet the hair thoroughly. Repeat treatment daily.

**To Control Blood-Sucking Lice:** Apply to the infested areas of the animal, using a stiff brush to get the spray to the base of the hair. Repeat every 3 weeks.

# **POULTRY AND POULTRY HOUSES**

**To Control Poultry Lice:** Spray roosts, walls and nests or cages thoroughly. This should be followed by spraying over the birds with a fine mist.

To Control Bedbugs and Mites In Poultry Houses: Spray crevices of roost poles, cracks in walls, and cracks in nests where the bedbugs and mites hide.

## STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage and disposal.
