**On Livestock**

**GOATS, SHEEP, CATTLE (Beef and Dairy), HOGS AND HORSES To Control Horn Flies, Face Flies, House Flies, Mosquitoes and Gnats:** Apply a light mist sufficient to wet the surface of the hair. For face flies, spray face and head, but do not spray into eyes.

**To Control Stable Flies, Horse Flies and Deer Flies:** Apply 2 fluid ounces per adult animal, sufficient to wet the hair thoroughly. Repeat treatment daily.

**To Control Blood-Sucking Lice:** Apply to the infested areas of the animal, using a stiff brush to get the spray to the base of the hair. Repeat every 3 weeks.

**POULTRY AND POULTRY HOUSES**

**To Control Poultry Lice:** Spray roosts, walls and nests or cages thoroughly. This should be followed by spraying over the birds with a fine mist.

**To Control Bedbugs and Mites In Poultry Houses:** Spray crevices of roost poles, cracks in walls, and cracks in nests where the bedbugs and mites hide.

**STORAGE AND DISPOSAL**

Do not contaminate water, food, or feed by storage and disposal.

**PESTICIDE STORAGE:** Store upright at room temperature. Avoid exposure to extreme temperatures.
