#### DIRECTIONS FOR USE: READ ENTIRE LABEL BEFORE USING

**Ornamentals:** Mix 1-2 quarts in 100 gallons of water and apply as a drench for seedlings and transplants.

#### Turf:

*Greens and Tees - Newly seeded or grow-in* — Use 1 quart per 10,000 sq.ft. in at least 10 gallons of water and repeat as needed. To deliver 1/2 lb of phosphorus per 1,000 sq.ft. — Mix 1 pint in sufficient volume of water and repeat as needed to enhance rooting.

Hydroseeding— Mix at above rates with seed slurry mixture for ease of application.

Foliar Application: Use 2-4 quarts per 100 gallons of water. Cover foliage thoroughly to point of runoff.

#### Spray coverage and drift control:

To optimize spray coverage or deposition, and to reduce drift, include Droplex® adjuvant.

#### MIXING AND HANDLING INSTRUCTIONS

Put 1/3 to 2/3 of total desired water volume in tank. Add adjuvant(s) and pesticide(s) if desired and agitate until thoroughly mixed. Add desired amount of **Gravity L Amp** and agitate until thoroughly mixed. Fill tank with remainder of desired water.

Caution: Check chemical mixture compatibility using a jar test.
