GENERAL INFORMATION

Gravity L KELP PLUS is a 100% flowable product for use in fertigation systems and spray equipment. This product may be used on all types of ornamentals, trees, turf, and other plants. Agitation is required. Additional applications should be made immediately prior to or following stress periods such as cold or drought.

DIRECTIONS FOR USE

READ ENTIRE LABEL BEFORE USING. SHAKE WELL.

When mixing **GRAVITY L KELP PLUS** with another product, always conduct a jar test and test on a small area to ensure compatibility. Fill half the spray tank with water and start agitation, add product then fill remainder of the tank with desired solutions.

IRRIGATION/FERTIGATION: This product can be applied through standard irrigation equipment. A water to product ratio up to 200:1 or more is acceptable.

TURF APPLICATION: Apply 2-6 fluid ounces per 1000 square feet every 1-4 weeks, or as needed. Use at least 20 gal of carrier water per 1 gal of product.

DO NOT APPLY NEAR WATER, STORM DRAINS, OR DRAINAGE DITCHES. DO NOT APPLY IF HEAVY RAIN IS EXPECTED. APPLY THIS PRODUCT ONLY TO YOUR LAWN/GARDEN, AND SWEEP ANY PRODUCT THAT LANDS ON THE DRIVEWAY, SIDEWALK, OR STREET, BACK ONTO YOUR LAWN/GARDEN.

ROOTING and TRANSPLANT: Add 15-20 fluid ounces of product to 20 gallons of water and apply as a foliar or drench application Re-apply as needed.

TOP DRESSING/SEEDING: Mix 0.25-0.50 gallons to a minimum of 50 gallons of water and apply to soil before or after seeding. Re-apply as needed.

WATERING: Mix 0.50 gallons with a minimum of 100 gallons of water and water regularly.

Note: For application rates suitable for your geographical area or the maximum allowed non-nutrient application rates per acre, consult a trained soil specialist (local horticulturalist) or contact the manufacturer or distributor.
