DIRECTIONS FOR USE
READ ENTIRE LABEL BEFORE USING

Once springtime water temperatures have stabilized at or above 65 degrees, initially apply 6 – 8 pounds of Trophy Maker fertilizer per surface-acre in a manner that allows thorough distribution throughout the pond or lake. Add incremental amounts of Trophy Maker (3 – 4 pounds per surface-acre) every two weeks until a satisfactory phytoplankton “bloom” has been achieved. Maintain the desired level of phytoplankton bloom with similar incremental amounts, as needed, throughout the period when water temperatures are above 65 degrees F.

Aquatics:

Initial Dose: 6-8 lbs per surface acre

Maintenance Dose: 3-4 Lbs per surface-acre as required to maintain phytoplankton “Bloom”.

DO NOT OVER FERTILIZE, AS FISH COULD BE HARMED BY SEVERE OXYGEN FLUCTUATIONS WHICH COULD RESULT FROM EXCESSIVE PHYTOPLANKTON POPULATIONS.

Virginia: This product is being used in accordance with the recommended application rates established by the VA Nutrient Management Standards & Criteria.

This lawn fertilizer contains phosphorous and is only for non-agricultural use on (i) turf during its first growing season, (ii) on turf areas being repaired or renovated, and (iii) on turf where a soil test performed within the last 3 years indicates a phosphorous deficiency. This fertilizer is not for the routine maintenance of turf.
