Green Soybean IDC™ is a water soluble dry 6% Iron ortho-ortho EDDHA product. The use of Fe-EDDHA is recommended in areas that experience Iron Deficiency Chlorosis (IDC) or in crops that benefit from additional iron.

For use in a balanced fertility program for all crops requiring iron. User should seek the advice of a certified crop advisor or trained agronomist. For specific crop recommendations in your area, consult your state's recommendations. For best results, follow good agronomic practices and tissue test.

MIXING INSTRUCTIONS

When making solutions of this product, add **Green Soybean IDC™** directly to water, using agitation. Continue stirring until fully dissolved.

Check chemical mixture compatibility using a jar test prior to application.

RATE RECOMMENDATIONS

Soybean In-furrow application

Mix 3 lbs. of product in water at a minimum ratio of 1 lb product: 2 gallons water and apply in-furrow at 6 – 10 gallon per acre. Higher water volumes allow for easier mixing and complete dispersion of the product.

Sorghum In-furrow application

Mix 1 - 3 lbs. of product in water at a minimum ratio of 1 lb product: 2 gallons water and apply in-furrow at 6 – 10 gallon per acre. Higher water volumes allow for easier mixing and complete dispersion of the product.

Sugar beets In-furrow application

Mix 1 - 3 lbs. of product in water at a minimum ratio of 1 lb product: 2 gallons water and apply in-furrow at 6 – 10 gallon per acre. Higher water volumes allow for easier mixing and complete dispersion of the product.

Dry beans In-furrow application

Mix 1 - 3 lbs. of product in water at a minimum ratio of 1 lb product: 2 gallons water and apply in-furrow at 6 – 10 gallon per acre. Higher water volumes allow for easier mixing and complete dispersion of the product.

For use in other crops

Mix 1 – 3 lbs. of product in water at a minimum ratio of 1 lb product: 2 gallons water. In-furrow or soil application is recommended.
