GENERAL INFORMATION

HELENA® 19-1-6 is intended for use in foliar applications. Foliar fertilization is intended as a supplement to a regular fertilization program and will not, by itself, provide all the nutrients normally required by crops or other intended plants. HELENA® 19-1-6 may be applied to turf using conventional spray equipment. Utilize soil and/or tissue tests to determine the proper rate and frequency of application.

GENERAL RECOMMENDATIONS

Cool Season Turf: Apply 3-4 oz. per 1,000 sq. ft. every 7-14 days as needed to maintain turf vigor. Use the higher rate for fairway application. Apply with 1 to 3 gallons of water per 1,000 sq. ft.
 Warm Season Turf: Apply 4-8 oz. per 1,000 sq. ft. every 7-14 days or as needed to maintain turf vigor. Use the higher rate for fairway application. Apply with 1 to 3 gallons of water per 1,000 sq. ft.

BLENDING INSTRUCTIONS

Fill mix tank ½ full of water and start agitation. Properly measure and add HELENA® 19-1-6 to the tank and finish filling with water and/or other water soluble material.

TANK MIXING

HELENA® 19-1-6 may be tank mixed with CoRoN® turf fertilizers for longer lasting residual N. However, concentrated blends with CoRoN® need to be jar tested.
