DIRECTIONS FOR USE

- Shake well before use. • Designed to be applied to the soil. • ZAP® should be applied when soil analysis identifies the need and proper rate of application for this product. • Best results will be obtained when application is concentrated in the active root zone. • First application should be 15 to 20 days before planting, bud break or root flush or at the onset of dormancy. • Can be applied in combination with compatible plant growth regulators, pesticides, or other liquid fertilizers. • If compatibility is in question, jar test a small quantity.
- Do not apply this product in concentrations greater than 10%.
- Do not apply HUMA GRO® nutrients during the hottest time of the day or to plants under drought or flood stress. • Application timing, intervals and rates may vary according to individual crop requirement, stage of development, available nutrient levels in the soil, and overall nutritional status of the crop. • Applications can be made as often as every 15 to 20 days as needed. • Soil moisture is required for maximum bioactivity. If soil is dry, moisture should be provided by irrigation.
