GENERAL INFORMATION

Hydra-Hume® DG "Coated" is a Leonardite mix, rich in humic acids containing perhaps the highest concentration of humic acids available from raw Leonardite. Products containing humic acids, such as Hydra-Hume® DG "Coated", may increase uptake of micronutrients.

SUGGESTED DIRECTIONS

Hydra-Hume® DG "Coated" can be applied to all crops including: trees, vines, ornamentals, lawns and garden landscaping.
 Apply 40 - 80 pounds per acre per year.
WARM SEASON GRASSES: 1-2 lbs./1,000 sq. ft. in early spring & late fall. Problem spots may benefit from additional applications.
COOL SEASON GRASSES: Use at 1-2 lbs./1,000 sq. ft. as a top-dress after aeration. Mix with sand media if possible.
TREES, SHRUBS, WOODY ORNAMENTALS AND BEDDING PLANTS: Ring 2-8 oz. around base of trees and shrubs. Use higher rates on larger species. Broadcast 1-2 lbs./1,000 sq. ft. into ornamental beds.
