HYDRA-HUME® DG is a leonardite mix, rich in humic acids containing, perhaps, the highest concentration of humic acids available from raw leonardite. Products containing humic acids, such as HYDRA-HUME® DG, may increase uptake of micronutrients.

SUGGESTED DIRECTIONS

HYDRA-HUME® DG can be applied to all crops including: vegetable crops, row crops, and field crops.

Apply 40 pounds per acre per year. May be applied anytime during the year. First preference would be to broadcast in the fall after deep tillage. Second preference is to broadcast pre-plant up to first blossom.
