DIRECTIONS FOR USE

MIXING INSTRUCTIONS

Shake Well Or Recirculate Before Use.

1. Fill sprayer 1/3 to 1/2 full of water
2. Add dry flowables or dispersible granules
3. Add emulsifiable concentrates
4. Continue to agitate until tank is 3/4 full
5. Add Iconic® last to the agitating spray tank

RECOMMENDED RATES

2 quarts per 100 gallons

STORAGE AND DISPOSAL
