DIRECTIONS FOR USE

TURF:	
RECOMMENDATIONS FOR USE WITH INJECTION:	Inject at a rate of 1 quart per acre. Apply in a minimum of 50 gallons per acre. Repeat application each month or as required during the growing season.

AGRICULTURAL APPLICATIONS:	Inject at a rate of 1-4 quarts per acre.

RECOMMENDATIONS FOR USE WITH CONVENTIONAL SPRAYERS:	Apply at a rate of 1 oz. per 1000 sq. ft. in a minimum of 1 gallon of water (32 mL/4 L water/100 m ²). Irrigate as normal. Repeat application each month or as required during the growing season. INJECTOR® can be applied without watering-in afterward. (Irrigate before next mowing or leave baskets off.)

MIXING

Prior to any pesticide application, all spray mixing and application equipment must be cleaned. Carefully observe all cleaning directions on the pesticide(s) label(s). Fill spray tank full with water and begin agitation. Add INJECTOR® to the spray tank and mix for 1 to 2 minutes. Add pesticides as directed by labeling or in the following sequence:

1. Dry flowables or water dispersible granules
 2. Wettable powders
 3. Flowables
 4. Solutions
 5. Emulsifiable concentrates
- Continue agitation.
