FOR USE WITH AQUATIC, FORESTRY, INDUSTRIAL, MUNICIPAL, ORNAMENTAL, RIGHTS-OF-WAY, TURF AND UTILITY PESTICIDAL SPRAY MIXTURES ONLY.

INLET® incorporates the properties of a nonionic wetter/spreader surfactant when used in pesticidal spray mixtures. INLET® is designed to quickly wet and spread a more uniform spray deposit over leaf and stem surfaces. INLET® can positively affect pesticide spray application and pesticide efficacy. INLET® is recommended for use with those pesticides whose label recommends a wetter/spreader type adjuvant or a nonionic surfactant.

DIRECTIONS FOR USE

The addition of an adjuvant to some pesticides or pesticide tank mix combinations may cause phytotoxicity to the foliage of susceptible plants. Prior to the addition of INLET® to spray mixes, the user or application advisor must have experience with the combination or must have conducted a phytotoxicity trial or must take the recommendations from the labels of the products to be tank mixed.

For most applications, use enough INLET® to allow for uniform wetting and deposition of the spray onto the leaf surface without undue runoff.

*General Use: Use 1/2-4 pints per 100 gallons of spray.

For use in forestry, aquatics, and industrial, municipal, utility, and rights-of-way applications: Use enough INLET® to allow for uniform wetting and deposition of the spray on to the leaf surface without undue runoff. In difficult wetting situations (such as hard water on mature waxy foliage) the higher rates may be required. For more specific rates, refer to the following dosage chart:

*Note: The above use recommendations are considered to be adequate for most uses. Some pesticides, however, may require higher or lower rates for optimum effect. Follow the pesticide label directions when this occurs.

MIXING

Prior to any pesticide application all spray mixing and application equipment must be cleaned. Carefully observe all cleaning directions on the pesticide(s) label(s). Fill spray tank one-half full with water and begin agitation. Add pesticides as directed by labeling or in the following sequence:

- 1. Dry flowables or water dispersible granules.
- Wettable powders
- 3. Flowables
- 4. Solutions
- 5. Emulsifiable concentrates and continue filling.

Add INLET ™ last and continue agitation.
