### GENERAL INFORMATION

INSIST® 90 PLUS is a surfactant which contains nonionic surfactant and anionic surfactant. This product is used to improve the spreading and effectiveness of agricultural pesticides such as, herbicides, insecticides, fungicides and miticides. INSIST 90 PLUS is designed for use with pesticides in field and row crops, forestry, range and pasture and non-crop vegetation management use sites.

## DIRECTIONS FOR USE

INSIST 90 PLUS use rates will vary according to the amount of this product that will achieve smooth, uniform coverage on the plant surface. Use the specified use rate to achieve smooth and uniform coverage for the intended application.

**NOTE:** When mixing INSIST 90 PLUS with other agricultural chemicals, all product labels and directions should be read and followed to ensure chemical compatibility and proper usage.

## USE RATES

**HERBICIDES:** Use 1-4 pints (16-64 fl. oz.) per 100 gallons of spray solution.

**INSECTICIDES AND ACARICIDES:** Use 1/2-2 pints (8-32 fl. oz.) per 100 gallons of spray solution.

**FUNGICIDES:** Use 1/2-2 pints (8-32 fl. oz.) per 100 gallons of spray solution.

**DEFOLIANTS AND DESICCANTS:** Use 1-4 pints (16-64 fl. oz.) per 100 gallons of spray solution.

**VEGETATION MANAGEMENT:** Use 2-4 pints (32-64 fl. oz.) per 100 gallons of spray solution.

**RANGE AND PASTURE:** Use 1/2-4 pints (8-64 fl. oz.) per 100 gallons of spray solution.

**FORESTRY:** Use 1-4 pints (16-48 fl. oz.) per 100 gallons of spray solution.

Not for aquatic use.
